WHAT IS THE PAGEANT?

The competition at Grand Session will include a written exam, oral presentation of some part of the ritual, inspection of regalia (regular officer's robe only), a personal interview with a panel of judges and stage appearance during the pageant. Also, a short essay or speech will be required. More information will be sent as entries are received.

WHO CAN ENTER?

Any member in good standing in her Bethel, who enjoys meeting the public, is knowledgeable of our Order and capable of representing Job's Daughters with fun-loving dignity, grace and charm. The contestant may not be a Past Miss Kansas Job's Daughter or the current Grand Bethel Honored Queen.

REQUIREMENTS

Miss Kansas Job's Daughter Contestants:

*16 years of age and cannot have reached the age of 20 by June 8 (day of Pageant).

*Completion of Registration Form and \$40.00 entry fee (Non-refundable).

*Loves Job's Daughters.

*Per the Bylaws the representative will be expected to represent Kansas in the Miss International Job's Daughter Pageant at Supreme Session, providing such pageant is held.

Junior Miss Kansas Job's Daughter Contestants:

*13 to 15 years of age.

*Completion of Registration Form and \$40.00 entry fee (Non-refundable).

*Loves Job's Daughters.

The entry fee is to be paid by the contestant or her Bethel. Checks should be payable to **Grand Session**. There will be a pageant breakfast and that fee will be paid at the time of registration with her Bethel.
