

# RECOGNITION AWARDS

## SUNFLOWER MEDALLION

- GIVEN TO A DAUGHTER WHO HAS SIGNED THE PETITION OF AN INITIATED CANDIDATE
- FOR EACH NEW INITIATE INITIATED AFTER 5, ADDITIONAL MINIATURE SUNFLOWERS ARE AWARDED
- INFORMATION EMAILED TO GC & VGC WITH INITIATE & SIGNER NAMES

## LILY OF THE VALLEY

- TO RECOGNIZE KANSAS JOB'S DAUGHTERS WHO HAVE SHOWN ACTIVE SUPPORT FOR A MINIMUM OF THREE (3) YEARS IN HER BETHEL AND/OR ANOTHER BETHEL AND JOB'S DAUGHTERS INTERNATIONAL BY UNSELFISH EFFORTS AND COMMITMENTS.
- THE DAUGHTER MUST HAVE REGULAR ATTENDANCE DURING THE ENTIRE TIME IN WHICH SHE IS BEING CONSIDERED FOR NOMINATION. REGULAR ATTENDANCE, FOR THIS AWARD SHALL MEAN PRESENT AT NO LESS THAN FOURTEEN (14) MEETINGS PER YEAR WHILE IN HIGH SCHOOL OR SEVEN (7) MEETING OR OTHER ACTIVITIES PER YEAR WHILE ATTENDING COLLEGE.
- THE DAUGHTER MUST HAVE ATTENDED THE ANNUAL SESSION OF THE GRAND GUARDIAN COUNCIL FOR THREE (3) YEARS AFTER TURNING THE AGE OF SIXTEEN (16). SHOULD THE DAUGHTER TURN SIXTEEN (16) DURING THE ANNUAL SESSION, THAT YEAR MAY NOT BE COUNTED AS ONE OF THE THREE (3) REQUIRED YEARS. THE NOMINATION MUST OCCUR BEFORE THE AGE OF TWENTY-FIVE (25). THE DAUGHTER DOES NOT BECOME ELIGIBLE FOR THE AWARD AND CANNOT BE NOMINATED UNTIL THE COMPLETION OF HER THIRD YEAR IN ATTENDANCE AT THE ANNUAL SESSION OF THE GRAND GUARDIAN COUNCIL.
- NOMINATIONS SENT TO THE GC BY FEBRUARY 15TH

## ROYAL PURPLE DEGREE

- THE DEGREE OF ROYAL PURPLE IS AWARDED IN RECOGNITION OF OUTSTANDING AND DEDICATED SERVICE BY A MAJORITY MEMBER TO JDI. IT IS INTENDED TO RECOGNIZE A MAJORITY MEMBER WHO HAS GIVEN TO THE ORDER IN A CAPACITY ABOVE AND BEYOND THE NORMAL CALL OF DUTY: AN OUTSTANDING CONTRIBUTOR TO THE ORGANIZATION.
- TO BE NOMINATED FOR THE DEGREE A MAJORITY MEMBER SHALL HAVE MADE MAJOR CONTRIBUTIONS TOWARD THE GOOD OF THE ORDER AND/OR TO A SPECIFIC BETHEL. THE MAJORITY MEMBER SHALL HAVE ACCEPTED AN APPOINTMENT AS A MEMBER OF A BCC AND HAVE MADE AN OUTSTANDING CONTRIBUTION TO THAN BCC ABOVE AND BEYOND THE USUAL BCC RESPONSIBILITIES. SERVICE AS A BETHEL MAJORITY MEMBER SHALL NOT BE CONSIDERED IN MAKING THE SELECTION. SERVICE TO OTHER MASONIC ORGANIZATIONS AND TO THE COMMUNITY ARE SUPPORT MATERIAL ONLY; SPECIFIC CRITERIA IS FOR OUTSTANDING SERVICE TO THE ORDER.
- THE NOMINEE MUST BE A MAJORITY MEMBER OF JDI. AT THE TIME OF THE NOMINATION SHE MUST BE AT LEAST TWENTY-FIVE (25).
- NOMINATIONS SENT TO THE ROYAL PURPLE COMMITTEE CHAIRPERSON BY FEBRUARY 15TH

## SILVER LINING

- TO RECOGNIZE AND HONOR ADULTS WITHIN THE BETHEL WHO ARE NOT MAJORITY MEMBERS OF THE ORDER, WHO HAVE RENDERED OUTSTANDING SERVICE TO JOB'S DAUGHTERS INTERNATIONAL. SHALL HAVE A MINIMUM OF FIVE (5) CONSECUTIVE YEARS OF OUTSTANDING SERVICE TO THE BETHEL AS AN ADULT.

## GOLDEN CLOAK

- TO RECOGNIZE AND HONOR MEMBERS OF THIS GRAND GUARDIAN COUNCIL WHO HAVE RENDERED OUTSTANDING SERVICE TO JOB'S DAUGHTERS INTERNATIONAL.
- A MEMBER MUST HAVE A MINIMUM OF TEN (10) YEARS OF OUTSTANDING SERVICE TO THE ORDER AS AN ADULT
- NOMINATIONS SENT TO THE GOLDEN CLOAK CHAIRPERSON BY FEBRUARY 15TH
